### CSIWCP

#### **Certified Self-Insured Workers' Comp Professional** *MASI's Certified Workers' Comp Professional Program*

The Certified Self-Insured Workers' Comp Professional is a designation offered by MASI to honor individuals who excel in their knowledge and ability as professionals in the Self-Insured Workers' Comp Industry. It consists of four modules: Workers' Comp Basics, Claims Management and Medical, Legal Principles, and Loss Prevention and Safety. Participants are allowed two years to complete the program. Six hours per year of continuing education in any recognized program is sufficient to maintain the designation.

#### **Continuing Education Credits**

Participants will be eligible for Six Hours of continuing education credits, per module. Applications will be submitted for MS CLE, Adjusters, P/C Insurance Agents and CCM.
